About us .

Association for Rehabilitation of Village and Impairment (ARVI) work towards the upliftment of indigenous, downtrodden, vulnerable, weaker sections of the community. Registered under the Indian Trust Act of India 1885, our focus is on children and person with disabilities as they are ignored due to their disability. We strive towards creating a positive, enduring change in the lives of children and people with disabilities living in abject poverty and undue inequality. The important aspect of our work is to integrate physically and mentally challenged community back in society through early intervention, multimodal therapy, skill development, and capacity building. Our Special Schools, and Home for mentally challenged are specifically designed to accommodate children in wheelchairs thereby ensuring their easy accessibility to education. We also constantly train and update the knowledge of Special Educators and Rehabilitation professionals under guidance of NIEPMD, Chennai and Sahyogi Scheme, so as to ensure effective training of C&PwDs. ARVI extends its relentless service to anyone in need of help and support irrespective of religion, caste, creed, race, ethnicity or gender.

Our programs

Education:

We run schools in different locations for CwDs: Arvi Special School - Dindigul, Arvi Trust Special School - Theni, Saranalayam Special School-Theni. Our schools hold valid certificates from NIOS (Biggest open school system in world)/ BOSSE. Our Special School on Wheels, Inclusive school programme are specialised educational programmes dedicated for the welfare of special children and children from downtrodden and weaker sections of community. These schools are structured in a way to foster the development of their language, cognitive understanding, special skills and abilities. We conduct activities broadly cover learning through informed knowledge, experimentation and experiences with new things. We alter our strategy study plan to fit their understanding capacity and help them choose their subjects based on their understanding and interest.

Home For mentally challenged:

It is no common scene to spot a mentally challenged individual in public places wandering aimlessly. We bring in such individuals, and offer them rehabilitation at our home which is specifically built for them. At Home, we offer a wide range of therapies, such as, occupational therapy, music therapy, spiritual therapy, and other activities such as sheep rearing, country chicken rearing, and maintain a kitchen garden. Through all these, we try to build their responsibility and self-worth.

Early Intervention:

We provide early intervention services for children with autism, hearing impairment, and intellectual disability. Early intervention broadly covers everything that a child with developmental disabilities require; we focus on providing speech therapy, communication skills training, physio therapy, daily living skills training to enable them to convey their thoughts and carry out their daily activities. We also extend to providing training at the door steps of children who have difficulty in commuting. Through this approach, we develop their social and emotional skills which can serve as a stepping stone for their integration in society.

Home-based training Programme:

ARVI has a unique approach to provide home-based training for children with developmental and intellectual disabilities. This programme

aims at providing special education, early Intervention training, physiotherapy training, communication skills, training on Daily Living Skills (DLS), and other therapy Services. Once the training is over, we mainstream the eligible children in nearby day care/Schools. As a part of this programme, we train Parents/Volunteers to look after special children in the absence of Special teacher/Therapist.



Vocational training:

The intellectually disabled adolescents will be trained in farming and different trades like Soap Powder, Soap Oil, toilet cleaners and having sales point to sell the items prepared. The unit is equipped with instructors, special educators, helpers and complex infrastructures. This pre vocational training will help students to go to vocational training. Additionally, we are providing one year training to Mild Mentally retarded persons in the field of Data Entry. For the placement and Trainer of Training services we are having tie-up with AMBA, Bangalore.

EARLY INTERVENTION CENTER FOR HEARING IMPAIRMENT:

With the support of Government and other stakeholders of society, our Early intervention (EI) training targets children between age 3 to 9 years by providing speech therapy and communication skills. We extend this facility at the doorsteps of children who have difficulty commuting to our location. We also provide transport facilities to children living some 25 kms away from our training centre. The main objective of this training is to mainstream and include children with disabilities in nearby schools after necessary training. Once we integrate them to the schools, we also provide support services for the students to continue their studies.

EARLY INTERVENTION CENTER FOR INTELLECTUALLY DISABLED AND AUTISM:

This Early intervention (EI) training programme also targets intellectually disabled and autistic children aged between 3 to 9 years. Under this programme, we identify special children and enhance their physical, and educational well-being through special education, speech, physiotherapy training and communication skills. Additionally, we also provide Daily Living Skills (DLS), as many children have difficulty in carrying out their day-to-day activities. Similar to intervention we do for children with hearing impairment, these special children are also integrated into mainstream schools after necessary training.

SPECIAL SCHOOL PROGRAMME FOR INTELLECTUALLY DISABLED:

ARVI Trust has 3 Special Schools dedicated for the welfare of Intellectually Disabled, CP and Autism Children, where we provide physio, occupational and speech therapy. Our schools hold valid certificates from NIOS (Biggest open school system in world)/ BOSSE. Eligible children will be enrolled with NIRAMYA health insurance. Here at our schools, we provide daily living skills training, vocational/farm training to increase their ability. As an additional effort, children are also involved in Sports/Paralympics training to encourage their participation in extracurricular activities.

Annual Program Highlights 2020-21

SPECIAL EDUCATION ON WHEELS:

Through this programme, we create awareness at the school-level, and among parents with the finest co-operation from the Dindigul district administration and local volunteers. This approach ensures that children with severe disabilities have access to quality education, therapies, and early intervention.

HOME-BASED PROGRAMME:

ARVI Trust reaches out to children with extreme disabilities and provides training at the comfort of their home through our home-based training programme. Some of the activities that we cover under this programme are:

- Special education and Early Intervention training
- Physiotherapy training and communication skills
- Training on Daily Living Skills (DLS), and other therapy Services
- Mainstreaming the eligible children in nearby day care/Schools
- Training to Parents/ Volunteers to look after special children in the absence of Special teacher/Therapist
- Provision of free assistive devices for the children in need
- Installation of low cost play parks with locally available materials.

INCLUSIVE SCHOOL PROGRAMME:

Our inclusive school programme is also recognized by NIOS (biggest open school in the world) and BOSSE. We follow an inclusive concept approach for the welfare of special children, downtrodden, weaker sections. Through this programme, necessary support is extended if a special is performing poorly in academics; special coaching is provided for those children with disabilities and dropouts. They also have flexibility in choosing the paper and selection of languages. Training in extracurricular activities with school subjects helps children perform better in their tests.


